

## Wagging Heart Kennels Guarantee

Wagging Heart Kennels, guarantees up to and no more than 24 months after the date of sale against all genetic defects. Should a genetic defect appear within this time period, we will either replace the puppy with another of equal value, or we will reimburse you the amount of and no greater than the purchase price of the puppy. In this situation, we will require a letter of diagnosis from your vet along with his/her telephone number before any reimbursement occurs.

Wagging Heart Kennels reserves the right to have the dog examined, health tested and X-rayed by their own veterinarian prior to any reimbursement being made. In the event of a puppy replacement, we will assume no shipping costs. Wagging Heart Kennels, takes no responsibility for veterinarian costs after the puppy or dog leaves the premises.

Due to varying kinds of dog food on the market and the different environmental conditions the puppies come in contact with, this guarantee becomes null and void unless the buyer agrees that NuVet Plus vitamins are given daily at the manufacturer's suggested dosage for these 24 months. Our guarantee does not include poisoning, accidents, negligence, dental bills or behavioural problems, as training philosophies and environments vary amongst individuals.

Buyer agrees to take full responsibility for his/her dog, providing quality food, shelter, adequate exercise and proper training. We understand that sometimes circumstances change and a dog owner cannot adequately provide for their dog. Should the buyer no longer be able to provide adequate care for the dog it must be returned to Wagging Heart Kennels to be re-homed. Never shall a Wagging Heart Kennels dog be placed in a shelter to be re-homed. At Wagging Heart Kennels we are responsible breeders ensuring that our dogs are placed in loving homes where the social, physical, and mental well being of the dog is well taken care of. In the event that the dog is returned to Wagging Heart Kennels within 2 weeks of purchase we will refund 50% of the purchase price. If the dog is returned to Wagging Heart Kennels after two weeks of purchase, no reimbursement shall be given.
